



Independent Auditor's Review Report on Quarterly Financial Results and Year to Date Results of the Company pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

To the Board of Directors of Yuken India Limited

1. We have reviewed the accompanying statement of unaudited financial results ("Statement") of Yuken India Limited ("the Company") for the quarter ended 31 December 2017 and the year to date results for the period 1 April 2017 to 31 December 2017, being submitted by the Company pursuant to the requirements of regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. This Statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on the Statement based on our review.
2. We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, Review of Interim Financial Information Performed by the Independent Auditor of the Entity, issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures, applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
3. Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying Statement prepared in accordance with applicable Indian Accounting Standards prescribed under section 133 of the Companies Act, 2013, read with rule 7 of the Companies (Accounts) Rules, 2014 (as amended) and SEBI Circulars CIR/CFD/CMD/15/2015 dated 30 November 2015 and CIR/CFD/FAC/62/2016 dated 5 July 2016, and other recognised accounting practices and policies has not disclosed the information required to be disclosed in accordance with the requirements of regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, including the manner in which it is to be disclosed, or that it contains any material misstatement.

The Company had prepared separate financial results for the quarter ended 31 December 2016 and the year to date results for the period 1 April 2016 to 31 December 2016 in terms of the requirements of regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in accordance with applicable accounting standards prescribed under section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014 (as amended) and SEBI Circular CIR/CFD/CMD/15/2015 dated 30 November 2015 and CIR/CFD/FAC/62/2016 dated 5 July 2016, and other accounting principles generally accepted in India. The financial results for the quarter ended 31 December 2016 and the year to date results for the period 1 April 2016 to 31 December 2016 were reviewed by the predecessor auditors, Deloitte Haskins & Sells, who had issued an unmodified report dated 4 February 2017 on such financial results. These financial results have been adjusted for the differences in the accounting principles adopted by the Company on transition to Ind AS, which have been reviewed by us in respect of financial results for the quarter ended 31 December 2016 and the year to date results for the period 1 April 2016 to 31 December 2016. Our report is not modified in respect of this matter.
5. The Company has availed the exemption in respect of submission of Ind AS compliant financial information for the previous year ended 31 March 2017 along with the Statement, in accordance with the SEBI Circular CIR/CFD/FAC/62/2016 dated 5 July 2016. Hence, the Statement does not include the comparative financial information for the aforementioned period.

Notes

- The above results of the Company has been reviewed by the Audit Committee and approved by Board of Directors at their meeting held on 12 February 2018.
- These financial results have been prepared in accordance with India Accounting Standards ('Ind As') prescribed under section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and in terms of the Listing Regulations, as modified by Circular No. CIR/CFD/FAC/62/2016 dated 5 July 2016.
- The statutory auditors of the Company have carried out the limited review of these financial results for the quarter and nine months ended 31 December 2017. An unmodified opinion has been issued and the same is being filed with the stock exchanges along with the above results. The financial results for the quarter ended 31 December 2016 and nine months results for the period 1 April 2016 to 31 December 2016 were reviewed by the predecessor auditors. Differences in the accounting principles adopted by the Company on transition to Ind AS have been reviewed by the Statutory Auditors.
- In accordance with Ind-AS 18, revenue from operations for quarter ended 31 December 2017 and 30 September 2017 does not include GST (Goods and Service Tax), however, revenue from operations till period ended 30 June 2017 and comparative periods is gross of excise duty.
- The exceptional items for the quarter (₹ 91.56 lakhs) and nine months (₹ 274.68 lakhs) ended 31 December 2016 respectively is with respect to additional depreciation, due to change in the estimated useful life of buildings on account of relocation of existing plant to Malur-Hosur Road, Malur, Kolar district. Also, it includes gain on sale of foundry business to the extent of ₹ 37.29 lakhs for the quarter ended 31 December, 2016.
- The company initiated the relocating of the manufacturing facilities of Valves, Pumps and Power Units to the newly developed plant at Malur from September 2016. The activity is undertaken in phases to reduce the disruption in production and sales. Other expenses include onetime charge of ₹ 33.55 lakhs for the quarter and ₹ 148.52 lakhs upto 31 December 2016 on account of relocation of existing plant to Malur-Hosur road, Malur, Kolar district.

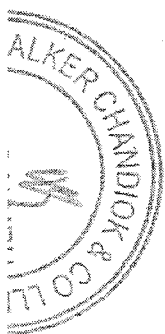

Notes on segment information:

- The Managing Director of the Company has been identified as the Chief Operating Decision Maker (CODM) as defined by Ind AS 108, 'Operating Segments'. The Managing Director of the Company evaluates the segments based on their revenue growth and operating income.
- Assets and liabilities used in the Company's hydraulic business are not identified to any of the operating segments, as they can be used interchangeably between segments. Management believes that it is currently not practicable to provide segment disclosures relating to total assets and liabilities since a meaningful segregation of the available data is onerous.
- Segment revenue and segment results represent amounts identifiable to each of the segments. Segment revenue includes revenue from operations, other operating income and other income. Other 'unallocable expense net of unallocable income' mainly includes interest income and expenses on common services not directly identifiable to individual segments and corporate expenses on common services not directly identifiable to individual segments and corporate expenses.
- During the current year, the Company has only one reportable segment. Figures for the nine months ended 31 December 2015 are in respect of business operations of the foundry division. Consequently to the approvals received from the Board of Directors on 21 September 2016, the Company had executed a Business Transfer Agreement during the year ended 31 March 2017 and has subordinated the business operations of its foundry division (effective from 1 October 2016) on a going concern basis by way of slump sale to Crolix Enterprises Private Limited, a 100 percent subsidiary of the Company.
- Prior period figures have been regrouped/reclassified, wherever necessary, to conform to the current periods' presentation.
