LISTING AGREEMENT

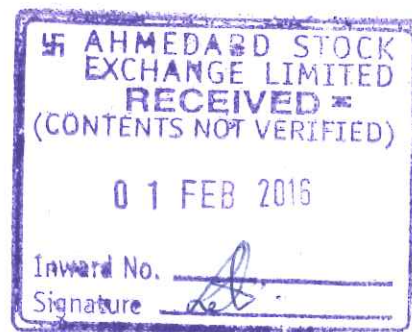
